
To provide an innovative and transformational K-12 learning community that empowers students with language-based learning disabilities.

THE STORY OF CHURCHILL



In the 1970s, learning disabilities were viewed as a medical condition to be remediated. Independent school teacher Harry Valentine, who stuttered and overcame his own social and academic challenges while in school, was frustrated by this limited approach and lack of educational resources for students with learning differences. He worked in conjunction with Arnold Schickler, who was inspired by the example of his niece, who had suffered from a traumatic brain injury. Together they gathered a team of partners, educators, and parents to found the Churchill School in 1972.



The Churchill School was founded with a class of seven students in a rented basement in the Community Universalist Church at 28 West 35th Street. The Churchill School was progressive for the times, taking a whole-child approach to education that included psychosocial development, an enriched curriculum, reading support, nutrition, and occupational therapy to develop students' strengths. In 1973, in response to increased demand, the School opened in a new location at 22 East 95th Street with a class of 45.

Through the years, the Churchill School continued this innovative, solutions-oriented approach to creating the best educational setting for students with learning differences.



Because graduate schools were not effectively preparing teachers, the Churchill School developed its own professional development programs and training, stressing real-world techniques in classroom management, problem-solving, and reading instruction. In 1980, the Churchill Center was founded with a mission to bring new knowledge and resources to families and teachers across New York City by regularly offering workshops led by nationally known experts in the field of learning disabilities education.

As the years went by and the demand for a quality education for children with learning disabilities increased, enrollment at Churchill grew steadily. The middle school was established in 1986, and the high school in 2000. Through the years, the Churchill School and Center maintained its ability to attract the best teachers – those who are dedicated, expert, resourceful, and exceptionally good at determining what each student needs to be successful. Churchill has remained committed to this ideal for fifty years.

Churchill moved to its current facility in September 2001. Since then, 20 high school classes have graduated. Our students have moved on to college and fulfilling careers – outcomes that were inconceivable to most only a generation ago. At every stage of our development here at Churchill, we have never lost sight of the importance of a holistic education model that incorporates the best and most innovative methods to educate children with language-based learning disabilities. We envision a world where students with language-based learning disabilities embrace their learning differences and see limitless possibilities. And as we look to the future, we seek only to improve our methods and embody our belief that every student deserves to have a great day at school.

FINANCIAL ASSISTANCE ENDOWMENT FUND

Thanks to you, we established the Churchill Financial Assistance Endowment Fund this year. At Churchill, our mission is to provide an innovative and transformational K-12 learning community that empowers students with language-based learning disabilities. Our vision is a world where students with language-based learning disabilities embrace their learning differences and see limitless possibilities.

The way to achieve our vision starts with access. And access is more than tuition. That is why our Financial Assistance Endowment Fund will support families in some of the ways they need it most – by assisting with paying for neuropsychiatric exams and legal fees.

Building and supporting socioeconomic diversity here at Churchill is an intentional and thoughtful process that is woven throughout everything we do. Our financial assistance program is at the heart of those efforts. It is a tool that allows children from all backgrounds and walks of life to have access to a community where they may see a future

full of possibilities and gain the knowledge and confidence to forge the paths that are just right for them.

CHURCHILL'S TRANSITION SUPPORT TEAM

One of the many examples of how members of the Churchill community support one another is Churchill's Transition Support Team. As Churchill transitions to complete independence in 2025, we want to make sure that every family has the resources and support they need.

To that end, we formed the Transition Support Team, which is made up of parents and caregivers, board members, and school professionals. This team worked together to create a robust outreach plan that included email communications, videos, webinars, live workshops, coffee meet-ups via Zoom, and other opportunities to connect and share information and experiences. The transition team provided input that built the Transition 2025 website, which contains helpful information like a glossary of terms, frequently asked questions, and workshop recordings. The team also crafted



the language for a survey to determine the needs of transitioning families. Members of the team reached out to families personally, offering their advice and personal knowledge to those dealing with the process for the first time.

We continue to meet regularly as a team and send out communications regarding the transition. We are immensely grateful for the partnership in this community that helps our students and families feel supported and cared for. Thank you!

ANTHONY RAPP'S WITHOUT YOU

This year, 10th-grade parents working on the New York production of Anthony Rapp's *Without You* generously arranged for the cast and crew of Churchill's spring musical to see the show and have a talkback with Anthony after the show. *Without You* is Anthony Rapp's inspiring memoir of love, loss, and resilience brought to life by Anthony himself, who performs songs from *RENT* as well as some



PREPARE PROGRAM

The Prepare program at Churchill is only possible because of you. The program uses age-appropriate materials and an evidence-based methodology to teach children the skills to set limits in situations that make them uncomfortable or are potentially dangerous. The program includes exploring how they feel about themselves (self-esteem, self-efficacy, and confidence), how they relate to themselves, and how they trust their instincts. It teaches our students situational awareness, how to make safer choices, and how to advocate for themselves and set boundaries,

originals. After the show, students talked with Anthony about his process, inspiration, and his profession. These types of activities broaden our students' perspectives and help them see life situations through different lenses. Our students wouldn't have meaningful and empowering experiences like these without your creativity, generosity, and support.

particularly when they are feeling unsafe. Providing children with this type of program lowers anxiety and gives them a sense of agency and self-reliance.

Most often, students have some understanding of these topics, but they have yet to have the opportunity to learn how to respond appropriately in moments of fear or intimidation. This program allows them to see how it feels to respond in a safe, supportive environment through repetitive role-playing.



Parents and teachers report that students who have completed this class are more relaxed, confident, and easier to talk to. They notice that they are more willing to face challenges and changes. The most ringing endorsements come from the students themselves. They report feeling less influenced by peer pressure, better able to assert themselves, and less intimidated about trying new things.

Because of you, we can offer this program to students beginning in 5th grade as they start to exercise more independence up until 10th grade as they move toward their graduation from Churchill. Every child should be able to experience feeling secure and comfortable with who they are, and you make that happen.



WOMEN'S CAREER DAY PANEL

Each year, on International Women's Day, female-identifying members of the Churchill community volunteer their time to serve on our Annual Women's Career Day Panel. They speak openly about their career paths, challenges, successes, and lessons they've learned along the way. Students ask questions and have lunch and deeper conversations with panelists in smaller groups afterward. Through activities like this, students get a sense of the opportunities awaiting them after they leave Churchill. They are able to see that our choices can take us in many different directions, and they get an authentic view of all of the different ways life can unfold.

This year's panel included women in law, finance, real estate, medicine, wellness, and entertainment. Students asked questions regarding tips for success, obstacles they faced throughout their career, how race or gender might have shaped their career, and any role models who might have influenced their path, professionally and personally. Our panelists answered these questions and many more from our eager students, who gained inspiration from these accomplished and influential women.




